Applications are invited from eligible applicants who wish to apply for grant of auto rickshaw permits from various Regional Transport Authorities throughout Maharashtra State.

I. *Eligibility Criteria

- 1. Applicant should be a citizen of India.
- 2. Age limit:- On the date of application, the age of the applicant should be 20 years and above.
- 3. Educational Qualification:- The applicant must be 10th standard pass. If enough applications of 10th pass candidates are not received, the applicants who are 8th standard pass, would be considered.

II. * General Terms and Conditions are as follows

- 1. Applicant shall have valid Transport category auto rickshaw driving license and public service vehicle authorization (badge) for auto rickshaw on the date of submission of application.
- 2. Applicant shall have knowledge of local language (Marathi) and local topography.
- 3. Applicant should have stayed in Maharashtra for at least 15 years continuously.
- 4. Successful applicant shall have to produce certificate from Police Department (Police Station where he/she is staying) stating that no cognizable offence is registered against him/her during the last one year
- 5. Successful applicant shall have to produce self-declaration stating that he/she is not in the service of Government/Semi Government/Private Company or any other organisation/firm (organized sector).
- 6. Successful applicant shall produce self-declaration stating that he/she is not holding another auto rickshaw/taxi permit in his/her name.
- 7. In case of applicants who have secured transport category autorickshaw driving license and autorickshaw badge from Regional Transport Office, Mumbai (Central) i.e. MH 01, he/she can apply either from Regional Transport Office, Mumbai (East) or Regional Transport Office, Mumbai (West); as per his/her choice.

8. The applicant should apply for permit only from the Regional /Deputy Regional Transport Office from where he/she has secured his/her badge.(Except those from Regional Transport Office, Mumbai (Central)who can apply either from Regional Transport Office, Mumbai (East) or Regional Transport Office, Mumbai (West)).

III. *About the auto rickshaw to be endorsed on the permit

- 1. In Mumbai, auto rickshaw to be endorsed on the permit shall use either CNG or LPG as fuel.
- 2. In the jurisdiction of offices where CNG/LPG filling stations are available, the auto rickshaw to be endorsed on the permit shall use the same (CNG/LPG) fuel and in other regions it shall be on petrol

3. Fitment of digital electronic fare meter of approved type is mandatory.

- 4. In Municipal Corporation areas, the vehicle to be endorsed on the permit shall be a new autorickshaw and in outside Municipal Corporation areas, the vehicle to be endorsed on permit can be an auto rickshaw up to the age of five years from the date of registration.
- 5. In future if Government/ Transport Commissioner/Concerned Authority decides to make it mandatory the fitment of GPS/GPRS, RFID Tag etc.in auto rickshaw, the permit holder shall have to install it on his own.
- IV. If an applicant submits more than one application, all his applications shall be treated as cancelled and the applicant willnot be eligible for selection process or the lottery draw.

V. Procedure to fill up online application.

- 1. Only online applications would be accepted for the grant of auto rickshaw permits as per this advertisement.
- 2. An eligible candidate can fill up web based online application form available on https://autopermit.mahaonline.gov.in from 27.01.2014 to 15.02.2014.
 - 2.1 Lottery draw will be carried out from eligible applications received. Tentative date for the lottery draw is 26th February, 2014 or any other subsequent date.
 - 2.2 Result of lottery draw will be published on 27 February, 2014 or subsequent date, on Transport Department's as well as on Mahaonline's website.
 - 2.3 Lottery winners/ selected applicants should submit original documents to concerned Regional Transport Office/Deputy Regional Transport Offices before 15 March, 2014. After the verification of the documents, the concerned offices will start issuing letters of intent for auto rickshaw permits from 1st March, 2014.
- 3. Detailed instructions regarding filling up online application form are available on https://autopermit.mahaonline.gov.in website.
- 4. The applications will not be considered for lottery/selection process unless processing fee is paid.

- 6. The list of Sangram Centers (in Grampanchayat) and Citizen Service Centers is available on www.mahaonline.gov.in website.
- 7. Applicant can fill up the applications either in English or in Marathi, through the option available on
- 8. The information marked as * is mandatory.
- 9. Applicants should mention full residential address along with correct PIN code.
- 10. Mentioning accurate contact number of applicant i.e. mobile number is Mandatory.
- 11. After reading and understanding the declaration, click on "I agree" button.
- 12. Check the information filled for its correctness and on satisfaction, click on "submit" button.
- 13. After the above step click on "Pay now" button for payment of processing fee.
- Transport Department has appointed only Mahaonline agency for acceptance of applications and not any other persons for the same. Applicants are advised not to deal with any unauthorized persons. Transport Department shall not be responsible for the consequences in such cases.
- VII. Online applications received after 06:00 p.m. on 15.02.2014 will not be considered for lottery draw.
- VIII. If it is observed during scrutiny that any applicant has deliberately given wrong information, such applications will be rejected at any stage and Transport Department will take legal action against such applicant.
